ADMINISTRATIVE ORDER
No. 069-2019

AN ORDER REORGANIZING THE MEMBERSHIP OF THE MUNICIPAL TRICYCLE REGULATORY BOARD (MTRB) OF THE MUNICIPALITY OF LA TRINIDAD.

WHEREAS, the Sangguniang Bayan of La Trinidad passed Municipal Ordinance 06-2016 which regulates the operation of motorized tricycles in Barangay Beckel, Barangay Ambiong and Sitio Dreamland-Peripin Bato of Barangay Pico;

WHEREAS, the same ordinance provides for the creation of a Municipal Tricycle Regulatory Board, indicating therein its composition, functions and duties;

WHEREAS, this office issued Executive Order No. 14-2017 appointing the members of the MTRB;

WHEREAS, the MTRB needs to be reorganized to replace and add members to fully and efficiently achieve the objectives of the committee;

NOW THEREFORE, I, ROMEO K. SALDA, as the duly elected mayor of La Trinidad, hereby reorganize the membership of the Municipal Tricycle Regulatory Board, to wit:

Section 1. COMPOSITION.

Section 2. FUNCTIONS. The Board shall assume the following functions and duties:

1. The Board shall be the sole governing body to oversee the formulation of policies, regulations and control of operations pertaining to the granting of franchise to operate tricycles within the municipality of La Trinidad.
2. Shall recommend and submit to the Sangguniang Bayan for appropriate legislation measures governing tricycle for hire such among others, the issuance or cancellation of franchise and fares, municipal fees, other charges and other traffic laws.

3. Receive and hear of applications prior to submission of their recommendation to the Sangguniang Bayan for the granting of franchise to operate.
4. Recommend to the Sangguniang Bayan applicants for the issuance of franchise.
5. Other measures affecting implementation of laws governing tricycles for hire.
6. Receive complaints from the public for appropriate action.¹


Section 3. MEETINGS AND QUORUMS. The board shall meet once every three (3) months or as necessary, which shall be presided over by the Chairman, and in his/her absence, the Vice Chairman. In the absence of the Chairman and Vice Chairman, the members present constituting a quorum shall elect among themselves who may preside for such meeting only. But in cases where the presence of the Chairman or Vice Chairman is required by law or by the rules and regulations of the Board, the meeting must only be presided by the Chairman or Vice Chairman.

The affirmative vote of a majority of the members present in a meeting shall be necessary to approve an action of the Board. The presiding officer shall not join in the voting except to break a tie.

A quorum shall mean the presence of a majority of the members.

Section 4. EFFECTIVITY. This order shall take effect immediately and shall be valid until revoked or amended.
