



ADMINISTRATIVE ORDER NO. 022-2019

AN ADMINISTRATIVE ORDER REORGANIZING THE MUNICIPAL CULTURE AND THE ARTS COUNCIL OF LA TRINIDAD, BENGUET AND DEFINING ITS FUNCTIONS

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that Local Government Units (LGU's) play an important role in the development, promotion and preservation of Filipino culture to encourage participation of the people in the development and preservation of Filipino identity;

WHEREAS, pursuant to the Local Government Code and DILG MC No. 2002-81 of the Municipality, the Local Culture and the Arts Council was created through Administrative Order No. 020-2014 by virtue of Sangguniang Bayan Ordinance No. 07-2005;

WHEREAS, in order to promote the Filipino Culture; instill nationhood and cultural unity, and raise the level of consciousness of the people on cultural values, conservation of historical and cultural heritage and resources must be done to remind us of our national culture and identity;

WHEREAS, there is a need to reconstitute and update the membership of the said Council due to some changes of members and sectoral representatives;

NOW, THEREFORE, I, ROMEO K. SALDA, Municipal Mayor, by virtue of the powers vested in me by Law, do hereby reorganize the Local Culture and the Arts Council of La Trinidad, Benguet:

Section 1. Composition. The Municipal Culture and the Arts Council shall be composed of the following:

Section 2. Functions. The Municipal Culture and the Arts Council shall perform the following functions:

1. Prepare an annual plan on culture and the arts consonant to the Medium Term Development Plan for Culture and the Arts, to be integrated in the Local Development Plan;
2. Formulate programs and recommendations to develop local culture and artistic talents;
3. Ensure the protection, preservation and conservation of the local cultural and historical heritage;
4. In coordination with the private sector, conduct cultural events such as cultural festivals, competitions, lectures, seminars, fora and symposia and set-up exhibits during fiestas and other related activities;
5. Conduct periodic consultations with all stakeholders to identify grassroots-based cultural concerns, issues and agenda;
6. Encourage the development of local cultural industries;
7. Conduct periodic inventory of local cultural objects and sites in coordination with the National Commission for Culture and the Arts; and
8. Coordinate with existing Local Culture and the Arts Councils.

Section 3. Meetings. The council shall meet regularly on a schedule agreed upon by its members or upon the directive of the Local Chief Executive.

Section 4. Effectivity. This Administrative Order shall take effect immediately and shall be valid until revoked or amended.
