**REORGANIZING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN TEAM OF THE
MUNICIPALITY OF LA TRINIDAD, BENGUET PROVINCE.**

WHEREAS, Joint Memorandum Circular No. 001, series of 2017 of the Department of Interior and Local Government and the Department of Transportation provided guidelines on the preparation and issuance of local ordinances, orders, rules and regulations concerning the Local Public Transport Route Plan (LPTRP);

WHEREAS, Section 4 of the said Joint MC directed the LGUs to designate focal persons who will be responsible for the preparation of the Local Public Transport Route Plan;

WHEREAS, Executive Order No. 07, s. of 2018 created and mobilized the Local Public Transport Route Plan Team of the municipality;

WHEREAS, there is a need to reorganize the Local Public Transport Route Plan Team to include members essential in the attainment of its objectives and goal and to replace members no longer in the agency or organizations they are representing;

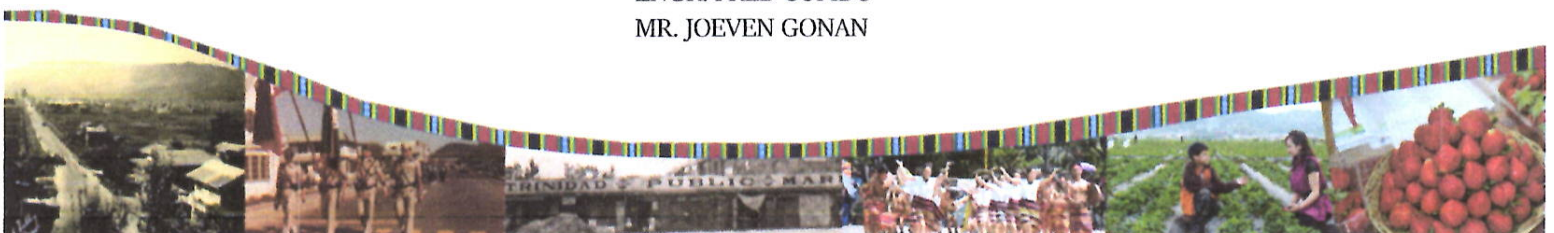
NOW THEREFORE, I, ROMEO K. SALDA, by the powers vested in me by law as the duly elected Municipal Mayor of the Municipality of La Trinidad, do hereby reorganize the LPTRP Team of the municipality as follows:



- SECTION 2. FUNCTIONS.** The Local Public Transport Route Plan Team shall perform the following functions:
- Prepare/Formulate the Local Public Transport Route Plan (LPTRP) of the LGU based and consistent with the LPTRP Manual and complying with the requirements indicated therein;
 - Secure the official inputs and/or comments of all stakeholders in the preparation of the LPTRP. Stakeholders shall include but not limited to commuter groups, transport groups, and the academe;
 - Attend Capacity Building trainings/programs or activities conducted by DOTr;

- SECTION 3. Functions of the TWG/Secretariat.** The Secretariat shall perform the following functions:
- Keep all records of the team and provide administrative and technical support to the team.
 - Organize and make all necessary arrangements for the meeting of the team;
 - Prepare minutes of the meeting;
 - Perform such other functions that may be necessary for the accomplishment of the above and those that may be assigned by the board.

SECTION 4. Effectivity. This Administrative Order shall take effect immediately and shall be valid until revoked or amended.
